It is on this 16th day of Sept.; 2015,


ORDERED THAT:

- 1) Declaratory Plaintiff, Township of South Brunswick, shall identify to the Court, Special

Master and all parties the names of its expert(s) by September 25, 2015.

- 2) All parties are permitted to notice and take the depositions of any other parties' expert(s) at a time and place convenient for the parties, pursuant to the applicable Rules of Court.
- 3) The Declaratory Plaintiff's Housing Element and Fair Share Plan, either adopted or in draft, shall be submitted to the Court, Special Master and all parties by November 9, 2015.
- 4) Leave to file a motion seeking to extend the temporary immunity granted to the Township of South Brunswick by way of Order dated July 31, 2015, beyond the current December 2, 2015, deadline is hereby **GRANTED**. Any such motion shall be filed no later than November 9, 2015, returnable on short notice on November 13, 2015. Said motion shall be filed with the Clerk of the Court, with copies to Chambers, the Special Master and all parties, and on notice to the Service List.
- 5) A Case Management Conference is hereby scheduled for Friday, November 13, 2015, at 2:00 p.m., with all parties and the Special Master in attendance, at which time the Court shall set forth a further Case Management schedule; and it is further

ORDERED that this Order shall be served upon all interested parties and the Special Master within seven (7) days of the date hereof.
