

**SOUTH BRUNSWICK TOWNSHIP  
PUBLIC NOTICE OF TAX LIEN SALE  
FOR NON-PAYMENT OF TAXES, ASSESSMENTS AND OTHER MUNICIPAL CHARGES  
TUESDAY, SEPTEMBER 19, 2023 at 8:30 a.m.\*\***

Public notice is hereby given that I, Kathie Gilliland, Collector of Taxes of the Township of South Brunswick, in the County of Middlesex, will hold a public Tax Title Lien Sale of property for non-payment of property taxes, improvement assessments, and other municipal charges on TUESDAY, SEPTEMBER 19, 2023 at 8:30 a.m.\*\* through on-line auction at <https://southbrunswick.newjerseytaxsale.com>. Properties listed for Lien Sale are those on which property taxes and/or other municipal charges for the year 2022 and prior remain unpaid pursuant to the provisions of the Tax Sale Law, Title 54, Chapter 5, Revised Statutes of New Jersey. Said properties will be sold subject to redemption at the lowest rate of interest, but in no case will exceed 18% per annum. Payment for liens purchased shall be made via wire transfer prior to the conclusion of the sale, or the property shall be resold. Properties for which there are no other purchasers shall be struck off and sold to the Township of South Brunswick at 18% per annum. Interest on subsequent liens shall be allowed as provided by law. Industrial Properties may be subject to The Spill Compensation and Control Act (NJSAS13:11 et seq) The Water Pollution Control Act (NJSAS13:10A-1 et seq) and the Industrial Site Recovery Act (NJSAS13:1K-6 et seq.) In addition, the Municipality is precluded from issuing a Tax Sale Certificate to any prospective purchaser who is or may be in any way connected to the prior owner or operator of the site. IN THE EVENT THE OWNER IS ON ACTIVE DUTY WITH THE MILITARY, THE COLLECTOR SHOULD BE NOTIFIED IMMEDIATELY. At any time before the sale, said Collector will receive payment of the amount due on any property with interest, costs and fees incurred by cash, cashier's check, money order, or certified check.
